# Resolution:

BE IT RESOLVED, that Agreement PR00000154 with Martin-McAllister Consulting Psychologists, Inc. to provide licensed psychological consulting services for prospective employment candidates for the Hennepin County Sheriff's Office during the period January 1, 2018 through December 31, 2018, with an amount not to exceed \$80,000 be approved; that the Chair of the Board be authorized to sign the agreement on behalf of the County; and that the Controller be authorized to disburse funds as directed.

# **Background:**

Agreement PR00000154 with Martin-McAllister Consulting Psychologists, Inc. provides for comprehensive testing and written evaluation of prospective employment candidates for the Hennepin County Sheriff's Office. The candidates are primarily for detention deputies, telecommunicators, and licensed deputies, and the purpose of the psychological testing is to determine the suitability for specific security roles.

Both an oral and written report will be provided, summarizing what the psychologist sees as the candidate's main strengths and developmental needs, as they would be seen on the particular job for which the candidate is being considered. Both reports also include the psychologist's recommendation regarding the candidate's suitability for the job. A clear recommendation of "recommend" or "not recommend" will be provided.
