Accept fund transfer from Hennepin County for increased environmental cleanup and construction costs associated with Estes Funeral Chapel relocation at Penn and Plymouth Ave N, Mpls; supp app of \$1,025,000 to the 2018 HCHRA capital budget

Resolution:

BE IT RESOLVED, that funding in the amount of \$1,025,000 be accepted from Hennepin County as identified in Hennepin County Resolution 18-0033; that a supplemental appropriation of \$1,025,000 to the 2018 Hennepin County Housing and Redevelopment Authority capital budget HRA: North Minneapolis Community Wellness Center (CP 1004688), increasing the appropriated project budget from \$18,650,000 to \$19,675,000, be approved; and that the Controller be authorized to accept and disburse funds as directed.

Background:

History: Hennepin County Resolutions 16-0277 and 17-0167 and Hennepin County Housing and Redevelopment Authority (HCHRA) Resolutions 16-HCHRA-0028R1 and 17 HCHRA-0025 authorized certain HCHRA actions to be taken in support of Hennepin County's North Minneapolis Community Wellness Center capital project (CP 0031735):

- Transfer and acceptance of \$18,650,000 from CP 0031735 (North Minneapolis Community Wellness Center) to CP 1004688 (HRA: North Minneapolis Community Wellness Center).
- The acquisition of property from the City of Minneapolis located on the southwest and southeast corners of Penn Avenue North and Plymouth Avenue North.
- Development agreement with Thor HQ Holding LLC (Thor Development) for the southeast corner of Penn Avenue North and Plymouth Avenue North for the construction of 76,000 square feet of office/commercial space, 16,000 square feet of retail space, and a parking facility; HCHRA acquisition of 420 parking stalls in newly constructed parking facility (parking acquired by the HCHRA will be conveyed to Hennepin County upon completion to serve the needs of the NorthPoint Health and Wellness Center).
- Land exchange agreement with Estes Funeral Chapel to relocate existing operations from its present location on the northwest corner of Penn Avenue North and Plymouth Avenue North onto land on the southwest corner; site development and construction of a "shell" building for Estes on the southwest corner.

Resolution 16-HCHRA-0036 authorized application and acceptance of a Minnesota Department of Employment and Economic Development (DEED) Contamination Cleanup grant and corresponding reduction to the budgeted bonding amount of \$197,440.

Resolution 17-HCHRA-0033 authorized Purchasing Agreement 4671A7 with Noor Construction Group for construction of the Estes Funeral Chapel shell building in the not-to-exceed amount of \$2,800,000.

Resolution 18-0033 authorized the transfer of an additional \$1,025,000 from Hennepin County's North Minneapolis Community Wellness Center capital project (CP 0031735) to the HCHRA for increased

environmental cleanup and construction costs associated with the project.

Current Request: This request seeks authorization to accept the transfer of \$1,025,000 from Hennepin County, and authorizing a supplemental appropriation of \$1,025,000 to the 2018 Hennepin County Housing and Redevelopment Authority Capital project budget HRA: North Minneapolis Community Wellness Center (CP 1004688) increasing the total appropriated project budget from \$18,650,000 to \$19,675,000.

Impacts/Outcomes: The adoption of this request enables the HCHRA to assist Hennepin County in advancing its capital improvement program (CP 0031735-North Minneapolis Community Wellness Center) in a city-approved redevelopment area.
