## **Item Description:**

Neg Agmt A188973 with Metropolitan Transportation Network, Inc. for the sale of surplus property located at 37th and University aves NE in Mpls, \$1,850,000 (recv)

## Resolution:

BE IT RESOLVED, that the executive director be authorized to negotiate Purchase Agreement A188973 with Metropolitan Transportation Network, Inc., or an affiliate, for the sale of surplus property located at 324 37<sup>th</sup> Avenue Northeast, 400 37<sup>th</sup> Avenue Northeast, and 3600 Fifth Street Northeast (PIDs 02-029-24-21-0001, 02-029-24-21-0003, and 02-029-24-21-0006) in the city of Minneapolis, during the period August 1, 2018 through July 31, 2019, with an estimated receivable amount of \$1,850,000; that following review and approval by the County Attorney's Office, the Chair be authorized to sign the purchase agreement, deed and all documents associated with the conveyance on behalf of the authority; and that the Controller be authorized to accept and disburse funds as directed.

## **Background:**

**History:** In 1991, Hennepin County Regional Railroad Authority (HCRRA) purchased property at 37<sup>th</sup> Avenue Northeast and University Avenue Northeast from Cargill, Inc. The purchase included property north of 37<sup>th</sup> Avenue Northeast (in Anoka County) that was sold to the Columbia Heights Housing and Redevelopment Authority in 1993. The remaining property consists of three parcels that encompass the entire block with the exception of two parcels owned by the Canadian Pacific Railroad Company (CP) that bisect HCRRA's property. The location of the parcels is highlighted on Exhibit 1.

The City of Minneapolis leased a 210 foot by 210 foot area from HCRRA beginning in 1997 for a "Gateway Art Project." The Minneapolis Park and Recreation Board also used a portion of the property for tree staging every spring. Both agencies are aware of HCRRA's plan to sell the property.

HCRRA declared the property located at 324 37<sup>th</sup> Avenue Northeast, 400 37<sup>th</sup> Avenue Northeast, and 3600 Fifth Street Northeast in the city of Minneapolis (PIDs 02-029-24-21-0001, 02-029-24-21-0003, and 02-029-24-21-0006) as surplus and authorized staff to proceed with a disposal of the property. The HCRRA parcels have a gross area of approximately 250,000 square feet and the CP parcels have a gross area of approximately 80,000 square feet, for a total of 330,000 square feet. HCRRA and CP agreed at the beginning of the disposition process to jointly advertise the property. HCRRA and CP will jointly negotiate separate purchase agreements for purchase of the entire block.

On February 9, 2018, HCRRA released a joint request for proposals (RFP) with CP for the purchase of the five parcels at 37<sup>th</sup> and University avenues NE; three responses to the RFP were received. Purchase prices offered by proposers ranged between \$1,850,000 and \$1,600,000 and are presented below from the highest offer to the lowest.

- 1. Metropolitan Transportation Network, Inc. for use as a transportation terminal and office space
- 2. Opus Development Company, L.L.C. for use as an industrial building with office space
- 3. Pan Asian Community Development for use as a mix of commercial uses in conjunction with affordable

## housing

**Current Request:** This request seeks authorization to negotiate Purchase Agreement A188973 with Metropolitan Transportation Network, Inc. for the sale of surplus property located at 37<sup>th</sup> and University avenues NE for an estimated receivable of \$1,850,000.

A staff review panel evaluated the three responses based upon purchase price and financial terms, business terms associated with the acquisition, use or uses proposed, and experience in similar type uses or projects. On the basis of this review, staff is recommending the negotiation of a purchase agreement with Metropolitan Transportation Network, Inc. Negotiation will be limited to one year, and if a sale is not completed by July 31, 2019, HCRRA will reopen negotiations.


**Impacts/Outcomes:** Approval of this request will allow for the disposal of surplus property not needed for HCRRA, Hennepin County or light rail transit uses. Further, the sale will allow for redevelopment of the parcel into industrial and office space.
