# **LAC's Purpose and Function**

Local advisory councils were established under the Minnesota Comprehensive Mental Health Services Act of 1987 and are mandated as part of the local mental health service system by MN Statute. The Mission Statement of the Hennepin County Adult Mental Health Advisory Council (hereinafter, the LAC) is to advise the County Commissioners, and County Administration and agencies, about policy, programs and services affecting persons with mental illness; to advocate for persons with serious and persistent mental illness; and to monitor, review and evaluate the allocation, adequacy and quality of mental health services within Hennepin County.

The LAC is comprised of individuals appointed to volunteer service positions by the Hennepin County Board of Commissioner under the Open Appointments Policy which governs appointments made to committees that advise the County Board on issues and programs, and help set policy within Hennepin County.

The Council is comprised of up to 23 voting members including:

- Consumers (6): individuals who are mental health service recipients:
- Family Members (6): individuals who are related to and/or support persons who live with mental illness;
- Mental Health Providers (6): individuals representing a community agency that provides services within Hennepin County including Community Support Programs; and
- At-Large (5): individuals representing a mental health advocacy organization, and individuals with expertise in a specific area of adult mental health including special populations such as African-American, American Indians, Hispanic, Asian, immigrants and/or refugees, older adults, transition age young-adults, etc.

The council monitors, studies and comments on the Hennepin County adult mental health system. The primary focus is on needs and services for adults with serious mental illness. The Council, in its advisory capacity, develops annual priorities and identifies unmet needs of persons living with serious mental illness in Hennepin County. The Council coordinates with Anoka Metro Treatment Center (AMRTC), the State Mental Health Advisory Council, and the Hennepin County Mental Health Court Steering Committee. Council Members are expected to attend monthly meetings and to serve on standing or ad hoc committees. The Hennepin County Human Services Department designates a manager to serve as official liaison between the LAC and the county board and administration. Additional department staff is designated to support Council operations and provide administration services.

# 2019 Unmet Needs

Approved by LAC January 17, 2019

### 1. Comprehensive support to find and sustain a home

- Maximize use of new Medicaid funding for supportive housing services that provide transition and sustaining services
- o Increase housing options designed to meet different cultural needs
- Improve timely access to emergency assistance benefit to both establish and sustain housing
- Provide risk mitigation funding to landlords for costs such as post-tenant housing repairs
- Develop more ongoing tenancy supports such as access to homemaker chore services when needed
- o Provide education and training in rights and responsibilities of tenants and landlords.

# 2. Further development of the criminal justice-mental health interface

- Expand co-responder model county-wide, and divert more 911 calls to emergency mental health services
- o Expand first responder crisis intervention training to county-wide
- o Explore the use of restorative justice approaches for offenders with mental illness
- Develop a county-wide body similar to the Minneapolis police mental health roundtable, and include people with lived experience and family members

# 3. Expanded opportunities and access to recovery and wellness resources

- Increase sustainable employment opportunities for people living with serious mental illness
- Increase access to transportation (e.g., public transit passes) for medical, wellness education, and psychosocial rehabilitation services
- Provide easier access to services that assist individuals to successfully navigate the mental health system
- Integrate wellness activities into mental health service delivery
- o Increase availability of transitional services from hospital to community

## **Perennial Issues**

In addition to the unmet needs listed above, the LAC wishes to highlight three additional perennial issues that should remain priorities for Hennepin County Health and Human Services and the community. These are:

- o The need to increase the numbers and diversity of the mental health workforce;
- The need to accept and characterize mental illness as a medical issue, and eliminate stigma and discrimination against people who live with a mental illness;
- The need to advocate for enforcement of federal mental health parity laws for private health plan insurers.

#### **Item Description:**

Human Services & Public Health resolution, including contracts and amendments to contracts with providers – Report 1911

#### **Resolution:**

BE IT RESOLVED, that the contracts, contract amendments and administrative actions of the Human Services & Public Health Department and Department of Community Corrections and Rehabilitation made pursuant to Chapters 256E and 393 of Minnesota Statutes, as detailed in Human Services & Public Health Contract Report 1911 be approved; that the report be filed in Contract Management Services; that the Chair of the Board be authorized to sign the contracts, contract amendments and administrative actions on behalf of the County; and that the Controller be authorized to disburse funds as directed. Such contracts are subject to ministerial adjustment, when such adjustments are done within the constraints of the approved Hennepin County Budget and when signed by the County Department Director or Designee.

### **Background:**

The contracted dollar amounts are based on estimates of program costs and/or utilization during prior periods. Funding for each contract is provided for within service categories in the Human Services & Public Health Department and Department of Community Corrections and Rehabilitation approved annual budgets. Occasionally new services are implemented which are not in the budget but which are fully funded under state or federal grants or other new funding.

Contracted dollar estimates are based upon prior year usage and are subject to fluctuation in placement patterns, service need, and cost shifts. Therefore, it may be necessary to process ministerial adjustments to contracts to increase or decrease contract amounts or to make minor service changes consistent with the department budget and strategic plan. Placement agreements are also processed administratively.

Contracts include services in the following areas: adult mental health; developmental disabilities; chemical health; adult housing; early intervention and family intervention services, day treatment services; emergency shelter; day care; training and employment services, interpreter services, health services, welfare advocacy, and various other human services. Expectations for ongoing outcome measurement are included in all new, renewal, or extended contracts. Outcome measures, which are developed by the county and contracted providers, assess the effectiveness of a service and its impact on an eligible recipient's condition or functioning level. Outcome information is used to modify or improve programs as well as to evaluate effectiveness of different types of intervention and providers. A detailed listing of the specific actions requested by this BAR and an explanation of all unusual items is reflected in the summary of the report.

#### **Item Description:**

Agmt A199722 with MN DEED–Rehab Services, accepting grant funding to provide extended employment services, 07/01/19–06/30/20, \$210,367 (recv)

#### **Resolution:**

BE IT RESOLVED, that Agreement A199722 with the Minnesota Department of Employment and Economic Development - Rehabilitation Services for the Extended Employment Program, during the period July 1, 2019 through June 30, 2020, in the receivable amount of \$210,367, be approved; that the Chair of the Board be authorized to sign the agreement on behalf of the County; and that the Controller be authorized to accept and disburse funds as directed; and

BE IT FURTHER RESOLVED, that sponsorship and acceptance of grant funding for this program by the Hennepin County Board of Commissioners does not imply a continued funding commitment by Hennepin County for this program when grant funds are no longer available.

#### **Background:**

The Minnesota Department of Employment & Economic Development—Rehabilitation Services provides an annual Extended Employment Grant to the Vocational Services Program (VSP) in Hennepin County's Human Services Department. This pays for all supported employment services. Funds are awarded according to a formula.

The VSP provides vocational rehabilitation services for approximately 120 Hennepin County residents who have a diagnosis of a serious mental illness and/or substance use disorder. VSP services include work evaluation, job placement, job skills training, and extended employment assistance. All individuals participate voluntarily and are referred by the Minnesota Rehabilitation Services Office or a Hennepin County Adult Behavioral Health operated case management team.

After a job starts, the staff assists participants with understanding job duties and with communicating with the supervisor and co-workers. Recent program outcomes show 75% of those placed kept their jobs at least 90 days and 76% were working one year later, with an average wage of nearly \$14.00/hour. VSP uses a holistic, person centered approach to supportive employment, recognizing that an individual's stability and wellness are integral to maintaining successful employment.
